1. 2022 Budget

Chief Rux reviewed the final budget with the Commissioners. Commissioner Pearsall asked about updating the background checks and drivers abstracts.

- b. Resolution 21-005 Property Tax Levy for 2022 Commissioner Pearsall made a motion to approve the Resolution 21-005 Property Tax Levy for 2022. Commissioner Black seconded the motion and the motion passed by unanimous vote.

2. Tender 13-1

Chief Rux reported that Tender 13-1 needed significant repairs, which could run about \$25,000 or more in repairs. Commissioner Hutchins asked about the life of the apparatus. Commissioner Hutchins made a motion to approve the repairs for Tender 13-1 that could cost approximately \$25,000. Commissioner Pearsall seconded the motion and the motion passed by unanimous vote.

COMMENTS FOR THE GOOD OF THE ORDER

Chief Rux asked for feedback from the Commissioners regarding the direction they were hoping for in 2022. Commissioner Hutchins asked if there were plans to cap the number of volunteers able to participate in our department, and Chief Rux replied that the goal was to have about 36 to 40 volunteers. Commissioner also asked about resident staffing at stations 2, 3 and 4, and also about the letter from the Commissioners to the Griffin Fire Association for the participation in the levy process.
