OLD BUSINESS

- 1. Bunker Gear Purchase Update
 - Chief Rux notified the Commissioners that the bunker gear quote had increased since the last board meeting discussion. Manufacturing prices have increased for 2022, and the new price is closer to \$133K for approximately 40 sets. The department has budgeted \$150K, but Chief wanted to make the Commissioners aware of the changes.
 - Commissioner Black made a motion to approve the price increase of the bunker gear equipment to approximately \$133,000. Commissioner Pearsall seconded the motion and the motion passed by unanimous vote.

NEW BUSINESS

- 1. Resolution 22-001 Budget 2022
 - Commissioner Black made a motion to approve Resolution 22-001 Budget 2022. Commissioner Pearsall seconded the motion and the motion passed by unanimous vote.
- 2. Resolution 22-002 Volunteer Stipends 2022
 - Commissioner Black made a motion to approve Resolution 22-002 Volunteer Stipends 2022. Commissioner Pearsall seconded the motion and the motion passed by unanimous vote.
- 3. Resolution 22-003 Surplus
 - Commissioner Black made a motion to approve Resolution 22-003 Surplus. Commissioner Pearsall seconded the motion and the motion passed by unanimous vote.

- Commissioner Pearsall and Hutchins will not be available for the March meeting. It was decided that the March meeting would be canceled. Also, similar discussion was brought up about the July meeting, but no decision was made.
